## COMPOSITION/INFORMATION ON INGREDIENTS

The compositions indicated correspond to the frame formulations representative of the product category, as defined at a European level by an expert group composed of representatives from poison centres, competent authorities, industry trade associations and the services of the European Commission. Frame formulations predefine ingredient types and their maximum concentrations, allowing products to be rapidly identified. Frame formulations are envisaged by Regulation (EC) 1223/2009 for the online notification of cosmetic products using the Cosmetic Products Notification Portal (CPNP), in accordance with Art. 13.

## IDENTIFICATION OF RISKS/INFORMATION FROM THE MANUFACTURER

May produce irritation in contact with the eyes.  
Take care when opening, due to the possible formation of gas inside the container.

*The following information does not refer to the product as supplied, but to the mixture obtained with products of the following categories: oxidation dyes, oxidation highlighters and bleaching powders (see respective product sheets). The product must not be mixed with any other product, and has been tested only with other products of the same brand.*

**Health warnings:** Do not apply to the scalp if this is damaged, irritated or affected by other disorders. As this product may provoke an allergic reaction in sensitive persons, it is advisable to carry out a preliminary trial for tolerance, as described below. Clean an area of 1 cm<sup>2</sup> behind the ear with alcohol and apply a small quantity of the product on the area prepared. Repeat the application two or three times, leaving the product to dry between applications. Wait 48 hours without washing. If after this time the customer experiences itchiness or reddening of the skin, do not use the

product. It must however be the decision of the customer whether to proceed with this tolerance trial or not. The hairdresser must refrain from expressing any conclusive assessment of the results of the tolerance trial.

Caution: The final product may produce hydrogen peroxide.

**Instructions for use:**

- carefully follow the instructions provided on packs or on the attached product information leaflet/wrapper/tag;
- wear suitable protective gloves (PPE);
- do not dye the eyelashes or eyebrows;
- use of a barrier cream is advisable;
- do not apply a permanent wave product immediately before or after dyeing the hair;
- apply the correct quantity, avoiding the contact of excess product with the forehead and neck;
- rinse well after application, emulsifying the product at first with a little water before rinsing more thoroughly;
- do not use on hair treated previously with a metallic dye;
- respect the recommended application times;
- take great care when using any sources of heat;
- immediately rinse away any traces of colourant mixture deposited on the skin and on clothing;
- use the mixed colourant product immediately;
- dispose of any unused mixed colourant product;
- do not leave the mixed colourant product inside a hermetically sealed container, as it may swell and explode;
- keep the product out of reach of children.

**Essential precautions:** The hairdresser must inform the customer of the information provided regarding precautions and warnings, both on contraindications and on the risk of possible allergic reactions. Do not use the product in any way other than as indicated in the specific instructions on the pack.

**FIRST AID MEASURES**

**Contact with eyes:** Remove contact lenses if worn and rinse thoroughly with abundant water. In case of persistent irritation seek medical assistance.

**Contact with skin/mucous membranes:** Rinse thoroughly with abundant water. In case of persistent irritation seek medical assistance.

**Ingestion:** In case of ingestion of significant quantities of the product, consult the nearest poison information centre.

**Inhalation:** In case of excessive inhalation, the product may produce irritations in the upper respiratory system. In poorly ventilated environments with a high concentration of water vapour, move the person affected into the open air. In case of persistent symptoms of irritation of the upper respiratory system, seek medical assistance.

**FIRE PREVENTION**

**Flammability:** May provide oxygen for combustion. In case of fire, extinguish with water or a fire extinguisher, and avoid breathing in smoke and vapours.

**PROCEDURES IN CASE OF ACCIDENTAL LEAKS OR SPILLAGES**

**Leaks or spillages:** Collect the spilt product, using sand and/or sawdust where necessary, and store all residues from cleaning in suitable containers for disposal as required by local regulations. Wash contaminated areas with water. Do not return spilt or leaked products to their original containers. Do not reuse spilt or leaked products.

**Personal protection:** Wear protective gloves, masks and glasses.

**HANDLING AND STORAGE**

**General precautions**

Carefully follow the instructions provided on packs. Do not mix with other products or substances unless indicated in the instructions. Continuous exposure to detergent products (soap, shampoos, liquid detergents) for professional reasons may cause deterioration of the natural moisturizing factor and the stratum corneum, which form the natural protective barrier of the skin. Deterioration of this barrier could cause lesions to the skin, which would therefore be more exposed to the action of external agents.

In these conditions, handling other products normally used in the course of professional activities without using the necessary precautions may give rise to phenomena of intolerance, which over the long term could develop into more serious forms.

**Optimal conditions of storage:** Store in a dry and well-ventilated place, at a temperature of no less than 5°C and away from naked flames, heat sources and functioning electrical appliances.

**Essential precaution:** Keep the product away from strongly reductant substances (products for permanent waves and hair straightener).

#### **PERSONAL PROTECTION/LIMITATION OF EXPOSURE**

The work environment must be adequately ventilated, using mechanical ventilation equipment if necessary (Title II, Legislative Decree 81/2008 and subsequent amendments).

If the employer identifies risks that cannot be avoided with other means, workers must be provided with suitable Personal Protective Equipment (PPE) (Arts. 77 and 75, Legislative Decree 81/2008 and subsequent amendments).

PPE must comply with the provisions of Legislative Decree 475/92 (Art. 76, Legislative Decree 81/2008 and subsequent amendments).

It is compulsory to use the PPE provided by the employer (Art. 20, Section 2 and Art. 78, Legislative Decree 81/2008 and subsequent amendments).

**Specific precautions:**

- wear disposable plastic gloves reaching up to the forearm (PPE) during all phases of application, handling and final rinsing;
  - it is advisable to protect the hands with a precautionary application of barrier cream;
  - use thoroughly cleaned work instruments;
  - do not use nickel-plated instruments;
  - do not wear jewellery or other ornaments.

#### **ENVIRONMENTAL PROTECTION**

The work environment must be adequately ventilated, using mechanical ventilation equipment if necessary. Points at which emissions of steam, gas, dust or other substances may occur must be located in specific areas equipped with local extraction or collection systems. #### **INFORMATION ON DISPOSAL**

The reference standard applicable to the disposal of cosmetic products is Part 4 of Legislative Decree 152/2006 (Environmental Code) and subsequent amendments.

Non-hazardous wastes from skilled trade activities (in the case of hairdressing salons this means empty used bottles and other containers) may be disposed of as municipal wastes if the municipality in question has implemented the provisions of Art. 198, Legislative Decree 152/2006 (Environmental Code), which lists the waste disposal responsibilities of municipalities.

Pursuant to Part 3, Section II, Titles III and IV of Legislative Decree 152/2006 regarding the protection of water resources, and pursuant to regional regulations, professional hairdressing activities are classified as being equivalent to civil residences that produce analogous domestic water wastes for discharge into the public wastewater system, on condition that they comply with the regulations established by the local authorities (e.g. municipalities and consortia) that manage the public wastewater system.

### **INFORMATION ON REGULATORY STANDARDS**

Finished cosmetic products are manufactured and sold in compliance with Regulation (EC) 1223/2009 and subsequent amendments.

Finished cosmetic products are specifically excluded from the field of application of European Union legislation regarding hazardous substances and mixtures (Regulation (EC) 1272/2008). They are also excluded from the requirements of Title IV of Regulation (EC) 1907/2006.

If the Risk Assessment Document (Art. 28, Legislative Decree 81/2008) indicates the need to establish a health monitoring programme, the employer must appoint a medical specialist (Art. 18, Section 1, Point a) to monitor workers with the pre-employment and periodic examinations required by law (Art. 41, Legislative Decree 81/2008).

Workers are obliged to participate in the health monitoring programme implemented by the medical specialist (Arts. 20 and 78, Legislative Decree 81/2008).
